SHC New Financial Year

The Council at its meeting of 12th May confirmed that the Members Fee remain at the same rate as this year. The SHC data base will soon be able to be accessed on line by members wishing to access Horse Registration, member records and for Online SHC Show Entries. This will save an enormous amount of duplication & copying when entering Shows as this information will be incorporated into the system.

Reminder: NSW members can download a 2015/2016 Member Application Form from www.showhorsecouncilaust.com.au under Membership/ Affiliates via your Club page. To get value from your membership it is important to remain current; Renewal dates are recorded so please don't let your membership lapse.

Important: When renewing please include your Member No. as it will remain the same on your new member card issued. The Richmond office will be the base for the issue of NSW member cards and for the administration of the new SHC data base which is now in operation. Members need to keep their details up to date with their Club in order that the new online system will work efficiently

At the major Pre Entry Events where Drug Testing is being carried out an adult as parent or Guardian of a Junior Competitor is required to be a SHC member also. A less costly Non Competitor/Non Rider membership is available should that person meet that criteria.

DISPUTES

From 1st July a Lodgement Form & Fee \$100 (non refundable) will apply to all complaints lodged with the Disputes Committee, the Form will be available on SHC Website.

Disputes matters are costly to deal with as include not just the committee's time but the considerable costs of travel & accommodation for a committee member from interstate, legal advice is also sought when necessary..

Complaints should be substantiated where possible & include witness statements & relevant documentation. Facebook Posts have become the new outlet for venting particular views that can cause offence; the Committee is not there to become involved in personal Disputes. Items that relate back to SHC Rules & could affect the good standing of the Council will be dealt with under its Social Media Policy.



Disputes Matters

Relating to SHC Qld member Mrs Julie Pearson (Responsible Officer) and owner of the horse Rayner Park (R.P.) Edenbridge Reg. No. HC6758 . The Dispute arising from Positive result to Drug Testing carried out at Northern Qld. Show Horse Championships on 22nd June 2014. The Committee found that a breach of SHC Rule 7.1 to 7.12 had occurred that fell within the definition of Misconduct. After full consideration it determined the Penalty was within the scope of SHC Competition Rule 7.8, Level 2, First Offence.

Penalty applied was:

1. Fine - \$500
2. 12 months suspension/ban of the horse Rayner Park (R.P.) Edenbridge rendering it ineligible for SHC Competition until 13th October 2015
3. 12 months suspension/ban of Mrs Julie Pearson, the Responsible Officer, rendering her ineligible for SHC Competition until 13th October 2015
4. 12 months suspension of Julie Pearson, Responsible Officer from Committee, Delegate and Official Judges List (if applies) until 13th October 2015
5. Forfeiture of Place, Sash Garland, Trophy Rug awarded for Champion Large Hunter Hack.
6. Full payment of associated drug testing costs of \$2,302.94
7. Publication of results in relation to penalties in accordance with Competition Rules 1.6 a) & 1.7 b)



Relating to SHC SA member Ms Cassie White,(Responsible Officer for horse "Dalmally Park Welfire" in the matter of on Positive result to Drug Testing carried out at SHC S.A. Horse Of The Year Show, 18th October 2014. The Committee found that a breach of SHC Rule 7.1 to 7.12 had occurred that fell within the definition of Misconduct. After full consideration it determined the Penalty was within the scope of SHC Competition Rule 7.8, Level 2, First Offence. Penalty applied in this instance was

- Fine of \$500 payable within 14 days.
- Suspension is applied to Responsible Officer Cassie White & to the Horse "Dalmally Park Welfire" in period taken from 18th October 2014 until 18th March 2015 rendering both ineligible for entry in SHC Competition prior to 18th March 2015.
- Suspension as SHC Delegate or SHC Judge List for 12 months from 18th October 2014.
- Forfeiture of Place and immediate return of Sash &/or Rider Award
- Full payment of associated Drug Testing Costs (Invoice copy attached) of \$2,525.66, payable within 14 days.
- Publication of results in relation to penalties in accordance with Competition Rules 1.6 (a) and 1.7

The terms of the Penalty have been complied with.

SHCA Database – Progress Report

Hi all,

The Show Horse Council database is coming along nicely, and is now available for members to login! At this stage, members will be able to search the stud book by horse name, microchip number or registration number. Details of owners are currently restricted to the name of the owner only – other details will be progressively available as soon as most members have renewed for the 2016 membership year.

Please make sure that your Affiliate/Constituent Affiliate has your current email address and has entered it into the database, as this will be required to get a password and be able to login. Once the membership module is made available, I would like to remind all members that their names, addresses and contact details will only be displayed if these boxes have been ticked on the membership renewal form.

Please also bear in mind that this is a work in progress, and I am still working through records – I will welcome emails from members if there are incorrect or out of date details in horse records, and will update/investigate as I get time. We will be working towards integrating measuring records with horse records and getting SHCA Panel Judges information integrated with member records at a later stage. On-line renewals and on-line show entries are at the testing stage – we will keep everyone posted!

Gentle Reminders....

I am only one person, and do my best to get everything processed as quickly as I can BUT please bear in mind that often there is more than one event closing at the same time, often in different States. To make my life a bit easier, before submitting paperwork, check the following:

- if it is a transfer of registration – please make sure that all signatures are on the reverse of the Certificate of Registration before you post it to me.
- I actually require the names of all individuals who are to be owners or part-owners of an NSH Registered horse. NSH Register Rules require ALL persons who are named as the owner of a horse to be current financial members of an Affiliate/Constituent Affiliate of SHCA. This means that details of all persons must be in the SHCA database, and marked as financial.
- all new registrations are required to provide a micro chip number. If in doubt – give me a call!

PLEASE NOTE NEW MEASURING FEES WILL APPLY FROM 1st JULY 2015

The motto of "BE PREPARED" really applies when it comes to having horses measured ,Exhibitors need to be proactive when presenting their horses for measure i.e. have horse ready & freshly shod. If borderline the opportunity will be given for a second measure on the day prior to the Certificate being issued.

The instances of requests for Remeasure have become a real unnecessary burden to the Council & to its volunteer measurers as in most cases the Remeasures have been unsuccessful. Under the Rules different measurers have to be used which mostly entail bringing Interstate Measurers in, again the Council has been carrying this cost. Therefore a non-refundable Fee of \$500 will apply to Remeasures from 1st July.
