

WELCOME TO 2025/2026 FIRST SHCA COUNCIL'S NEWSLETTER.

Many years ago Eileen Gibson and Bruce Flood formed the Hack Exhibitors' Association in Sydney. Over time the name and structure of the organisation has changed several times as it evolved into an Australia-wide and then an Australasian Show Horse organisation with members in all states and territories of Australia as well as New Zealand. During its existence SHCA and its earlier forms have conducted more than 30 Grand National Show Horse events at equestrian venues around the Sydney area. Each year SHCA members strive to qualify to attend the Grand National. Judges from the UK are invited to judge at these National Championships.

SHCA's governing body is its Council whose members are elected by NSW Affiliates and Interstate and NZ Constituent Affiliates to represent their groups to achieve best outcomes for SHCA and the Affiliates they represent. As at 25th August 2025 SHCA has 1889 financial members across all Australian States and Territories and New Zealand.
